TAX CREDITS AVAILABLE FOR CATH LAB EQUIPMENT

Since 2017, William Newton Hospital administration and board of trustees have been collecting applicable and current statistics that illustrate the strong need for a cath lab. William Newton Hospital has been approved to receive the maximum limit of tax credits available through the state of Kansas Community Service Program. This \$250,000

will be used to purchase new cath lab equipment so that we can treat blockages of the heart vessels right here in Winfield. Partner with us!
